- 2. No extra cost will be acceptable in addition to the quoted rates.
- 3. During the period if any problem reported by this office should be disposed within the minimum possible working hours. The Telephonic support should be provided during the period.
- 4. The interested agency should submit the FDR amounting to Rs.10,000/- infavour of Chief Accounts Officer, J&K AIDS Control Society.
- 5. The Prospective agencies should have at leaser 3 years experience of conducting quiz contests.
- 6. The agency will be selected in accordance with the Quality and Cost Based Selection (QCBS) method.
- 7. After the Quiz is over, the result can be displayed on the Portal.
- 8. The quiz has to be completed in three phases and result should be out after the completion of the quiz competition.

- 10. JKACS bear no liability in case of technical material, or software malfunction or defect (virus, bug) affecting the participants' computer system or computer equipment and data, and the related consequences on their professional, personal or commercial activity.

- 12. The web-based Quiz software should be accessible on mobile phones also.
